Privately Hosted Events

Thank you for reaching out to Women In Distress (WID) as a potential beneficiary of your fundraiser. We are very appreciative that you have chosen our organization to benefit from your efforts. There are some guidelines that we ask you and your organization to follow as outlined below.

We look forward to this partnership and the success of your event!

Privately Hosted events are events hosted and facilitated by people/companies outside of Women In Distress. For example, an office which usually dresses up for work has their employees donate monies to wear jeans for a week and the proceeds are donated to WID. There are many other ideas that can be discussed with the Privately Hosted Event Coordinator. The common thread with all of these events is that they are for or on behalf of Women In Distress and not *run* by WID. As well as the host/host company assumes the burden of the cost of the event/activity, due to limited budgeted funds for Women In Distress and does not have the ability to fund these types of events. If you should run into difficulty, we are here to help discuss options and solutions.

Staffing is another area that Women In Distress is limited in and cannot guarantee volunteers, speakers or tabling, but this can be further discussed and if planned ahead and pre-approved, WID may be able to still provide.

Guidelines

Please be mindful that events below cannot be considered:

- Anything inconsistent with WID's Mission of serving families.
- Involves a professional fund-raiser unless services are being provided on a volunteer basis.
- Involves the sale of tickets, products, or services by telephone, i.e. "Boiler-room telephone operations" which sells tickets to business or individuals.
- Do not comply with municipal, county, state or federal laws or regulations.
- Includes nudity or sexually explicit themes, content or activities of any kind.

Promotion & Use of WID Logo:

- The host is responsible for all ticket sales. If assistance from Women in Distress is required or the success of the event or activity, pre-approval from WID will be required.
- All materials using the WID name and/or Logo must be approved by Women in Distress prior to release of materials.
- If any promotional assistance from Women in Distress is required, please work with the event coordinator prior to approval of event.

Donations:

- The host must provide Women in Distress with a check or money order for the funds raised withing thirty (30) days after the event has taken place.
