
Capital Campaign: Building a Safer Tomorrow

Because Healing Cannot Begin Without A Safe Home



In May 2025, WID publicly **launched a \$15** million capital campaign to create transitional housing for survivors of domestic violence. This new facility will offer safe, affordable apartments where **survivors** can live for up to two years while accessing on-site therapy, job training, and financial education.

Unlike emergency shelter, this next step provides the time and support survivors need to rebuild their lives with autonomy and



stability. Residents will pay reduced rent, care for their households, and work toward long-term independence.

100% of our Board of Directors has already committed, and early donations & pledges have exceeded half of the goal. Now, we invite you to join us in building a safer tomorrow for survivors in our community.
